Below are the changes that concern the requirements or new definitions introduced in the ReMade Technical Standards.

Descriptive changes or changes related to definitions or to the contextual regulatory framework are **not** included in this list nor highlighted in the corresponding Technical Standard.

Paragraph of the ReMade Producers TS	Title of the Paragraph	Description of the change (highlighted in the text of the ReMade Producers TS)
4.1	Certification process	The Certificate must be sent by the CAB to the company and simultaneously to ReMade
4.2.2., letter g) 4.3.2.1	Product-related documents Documentation related to incoming materials	Indication of post-consumer waste origin
4.2.2., letter h)	Product-related documents	Removal of byproducts from the obligation to provide EWC codes
4.2.6	Internal audits	Internal auditor must have completed the dedicated ReMade Course
4.3.2.1	Documentation related to incoming materials	The list does not include examples; it must be considered exhaustive
4.3.2.2	Byproducts	Removal of the reference to the 264/2016 form (but all topics included in it are still reported) and removal of the requirement to send it to the Chambers of Commerce
4.3.7	Definition of the percentage of recycled, recovered and byproduct materials	Mass balance > (A/P) x 100 (minimum required by tenders always guaranteed)
4.3.8	Rebranding	Removal of the mass balance calculation; addition of the register
6.1	Sampling and duration of the verifications	Addition of products during certification: documentary verification only if they belong to the same family (otherwise on-site verification is also required)
6.1	Sampling and duration of the verifications	Requirement for a local technical expert in the case of audits outside Italy
6.1, Table 1	Sampling and duration of the verifications	Extra Italy FEE – Removed
6.1, Table 1, notes	Sampling and duration of the verifications	FEE Extension to suppliers: increase of 0.5 (not 1) for each supplier verified
6.1, Table 1, notes	Sampling and duration of the verifications	Obligation to audit, in the first year, the different production sites only if different processes take place
