

This means that today, everyone—**individuals, companies, and public administrations**—must commit to consuming fewer resources.

ReMade is the first scheme that certifies recycled and/or manufacturing by-product content, accredited and valid at an international level.


CERTIFIED RECYCLING FROM A TO Z

The certification process traces the journey of discarded items, showing how waste becomes secondary raw material and then a new product.

The entire production process is followed, certifying every step, for single-material and multi-material products.

What is ReMade

ReMade is the first product certification accredited for verifying recycled material and/or by-product content and valid at an international level.






APPLICATION

WHICH PRODUCTS CAN BE CERTIFIED?

ReMade certification can certify products or materials from any sector (construction, clothing, design, packaging), even multi-material, as long as they are made from recycled materials and by-products.



RECYCLED PRODUCTS

WHY CERTIFY RECYCLED PRODUCTS?

In many cases, simply claiming that a product is "recycled" to some extent is not enough. Consumers, companies, and public administrations need transparency regarding the sustainability characteristics of products, in order to prevent greenwashing practices.

That's why accredited certification is essential to highlight the actual percentage of recycled material contained in the final product, through a rigorous system for tracking materials, their supply chain, and their processing.

THE REMADE CERTIFICATION

What are the Advantages?

Not only does it provide competitive advantages, but it is a prerequisite for accessing exclusive business opportunities.

The Certification is undeniable proof of **transparency for clients and consumers** who want to choose truly circular products.

It is essential for participating in **Public Administration tenders**, as it is explicitly recognized in the Minimum Environmental Criteria (**MEC**) of Green Public Procurement (**GPP**) legislation.

It is also a fundamental requirement for accessing **incentives and tax breaks**.

THE CATALOGUE **FOR SIMPLIFIED SEARCHES**

ReMade connects certified companies committed to collective efforts for environmentally friendly communication.

Companies and their certified products are listed in a **continuously updated digital Catalogue**, available on the Foundation's website, organized by industry. Here, purchasing departments of private companies and public administrations can find references for the certified products and materials they are interested in.

It's an important visibility opportunity for certified producers, transparency for the certification scheme, and correct information for citizens.



THE REMADE CERTIFICATION

How is it Obtained?

Only products made entirely or partially from materials derived from waste recycling or by-products can receive ReMade Certification.



PRELIMINARY PHASE **INFORMATION**

The ReMade Foundation can provide companies with preliminary information on the certification process through the **Technical Standards** available online.

THE VERIFICATION **DOCUMENTATION AND AUDIT**

Checks are conducted by an accredited third-party **Conformity Assessment Body**, contacted directly by the company or via the Foundation. These include specific documentation checks and an on-site visit by the appointed auditor at the production facility.

Sometimes support from a ReMade-qualified **Consultant** can be helpful in preparing the necessary steps for the control process.

THE OUTPUT **THE LABEL**

Once certification is obtained, you can display a label proving the result. Highlighted are the percentages of recycled materials and/or reused by-products, along with analyses by the ReMade Foundation on reductions in energy consumption and climate-altering emissions resulting from recycling.

The ReMade certification scheme is overseen by **ACCREDIA**, Italy's sole accreditation body for certifiers, monitoring the professionalism, competence, and specific training of entities and auditors who perform checks and issue Certification.

THE LABEL

How can you Use it?

It's a recognized proof of the product's circular value in the eyes of clients and consumers.

It is available in various formats to suit different uses: **Extended** form as an attachment to technical documentation; **Compact** form, for websites or company brochures; **Essential** form, to affix on the product or its packaging.

THE CERTIFICATION PROCESS

What is Evaluated?

The central aspect is setting up a traceability model for material flows in the production process, transparency in operations, and relevant documentation.



REQUIREMENTS

MATERIALS, FLOWS, PEOPLE

Among requirements, the company must prepare a technical datasheet, constantly updated, clearly showing the components and their weight percentage, indicating those coming from recycling or by-products.

Each certified product must have a traceability report for its production system, including all material inputs, all operations performed, the process, and all material outputs.

Additionally, the company must appoint a responsible person for conformity to ReMade's Technical Standards, and all personnel involved in the certified process must be aware of their role.

SUMMARY

4 CATEGORIES

Based on compliance with all requirements, a percentage of recycled, recovered, and by-products content leads the product to one of these categories:

Over 90%  **A+**

60–90%  **A**

30–60%  **B**

Below 30%  **C**

It also assists public administrations in applying Green Public Procurement (GPP) regulations through personalized action plans.




